Contractor prequalification is valid for 2 years; however, your most recent financial statement must be submitted annually prior to the anniversary date in order to maintain a valid status. Contractors must “renew” their prequalification status by submitting a new application every 2 years.

Please allow at least 45 days for your application to be processed. Once your application is approved, you will receive a “Prequalification Certificate” listing the approved categories of work via standard mail.

Fees:

The fee for prequalification is based upon the type of financial statement submitted as shown below. Only checks and money orders will be accepted and are to be made payable to the “Director Finance.”

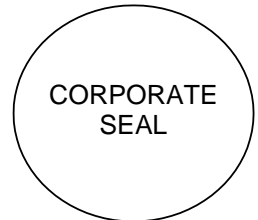
